**Important Notes :** 1-The school can accommodate maximum 27 students in classrooms proposed for sr. sec. level as the classroom size is 335 sq.ft. whereas, classroom should have minimum covered area of 500 sq.ft. 2- Physics, Chemistry and Biology labs are required to be shifted to rooms having size of 600 sq. ft. each, and library is required to be shifted to a room of 1200 sq.ft. 3-The school has submitted inspection report of fire safety issued by Fire Station officer, the school is required to obtain certificate in this regard.

School is required to appoint special educator & wellness teacher as per affiliation bye laws.
